State Representative Brian Baldrige updated the board regarding the state budget and other legislation:

- Transportation budget including an increase in gas tax
- Additional funding for indigent defense reimbursement to the counties
- Rural Development Loan/Grant-APEG Spec Building program
- Increased funding for protection and care of abused and neglected children

SALES TAX RESOLUTION-1ST PUBLIC HEARING HELD:

As previously advertised the first of two public hearings was held at 1:00 p.m. concerning a proposed resolution to change the purpose of a one-half of one percent (1/2% or 0.5%) sales tax from Adams County Regional Medical Center Permanent Improvements to County General Fund. This change would be effective April 1, 2020. Rachel Hamilton, *The Informer*, was present for the hearing. The hearing was opened to receive testimony for or against the proposed change. No testimony was received and no questions were asked at this time. A second public hearing is scheduled for Monday, April 1, 2019 at 1:00 p.m.

Court Administrator Greg Stauffer introduced newly appointed Court Magistrate Dave Hunter to the board. Mr. Stauffer also stated the present court computer system will need to be upgraded in the near future. Possible funding sources for this expense will be explored.

A meeting has been scheduled between Adams County EMS, Adams County Regional Medical Center and the board to discuss renewal of the LifeNet contract service from Physio Control. Linda Steele, EMS Administrative Assistant, will notify those involved.

BRANDI LANE-PRELIMINARY VIEWING SCHEDULED:

In accordance with the Ohio Revised Code a preliminary viewing has been scheduled for Brandi Lane which has been petitioned by Sam Kimmerly and others to be established as a public road in Oliver Township Road System. The date and time of the viewing is set for Monday, March 25, 2019 at 1:45 p.m.
