

The Board of Adams County Commissioners met in regular session on Monday, June 25, 2012, with the following members present: Brian Baldrige, Justin Cooper, and Roger Rhonemus. Clerk Diane Ward was also present.

It was moved by Brian Baldrige and seconded by Justin Cooper to approve the minutes of the previous meeting.

There was no further discussion and upon the call of the roll the vote resulted as follows:

EMS Director Etta Sparks met with the board to discuss part-time personnel and AED equipment maintenance. Ms. Sparks recommended Charles Brewer, III as a part-time EMTP at a rate of \$10.00 per hour on a 6-month probationary period.

The county will also be working with Family Resource Services (FRS) for dispatch of transportation services.
